## PRESCRIPTIONS REQUIRED BY RULES

### **R38**

(2) The Controlling Body shall issue a weight record card for a greyhound pursuant to the policy prescribed by the Controlling Body and an endorsement shall be made on the certificate of registration of the greyhound as to the date, place of issue and the serial number of the weight record card.

(3) The Controlling Body may, if satisfied as to the loss or destruction of a weight card, issue a replacement weight record card and endorse the certificate of registration accordingly.

***On the issue of a certificate of registration for a greyhound owned by a person registered by the Authority, the Authority shall issue a weight record card.***

**R54** (2) For Events conducted on a straight track the immediate activation of the lure by the lure driver shall result in the forward motion of the lure being commenced at a point prescribed by the Controlling Body and denoted by a disc or other mark.

***The lure shall be positioned directly in front of the centre of the starting boxes and adjacent to a disc or other mark positioned on the side of the track 8 metres in front of the starting boxes.***

**R105** (3) A trainer shall not train any greyhound unless the trainer has notified the Controlling Body in the manner prescribed that the greyhound is kept at the registered address of the trainer.

***Notification shall be in writing, by email or by the lodgement of the prescribed Kennelling Form.***

**LR24** (4) Licences that may be issued by the Authority are-

Trainer/Class 2 – permitting the holder to train not more than the number of greyhounds prescribed by the authority.

***Subject to the Local Laws of the area in which the kennels are situated and a consideration by Authority in a particular case, the prescribed number shall be 10.***

**LR24** (9) A registration issued shall, unless sooner cancelled by the Authority, or at the request of the holder, remain in force from the date it was granted until such time as prescribed by the Authority.

***The prescribed expiry time shall be indefinite.***

**LR24** (10) A person desiring to renew a licence or registration shall submit to the Authority the appropriate application together with the prescribed fee on or before the expiry date of the licence or registration or such other date prior to the expiry date as the Authority may prescribe.

***The prescribed date shall be not later than 31<sup>st</sup> May preceding the expiry date.***

**LR32** (1) A club proposing to conduct a meeting between 1<sup>st</sup> July and the 31<sup>st</sup> July in the following year shall make application to the Authority by the prescribed time for the allotment of the date on which the meeting is proposed.

***The prescribed time shall be not later than 31<sup>st</sup> March.***

- LR34** (1) Before being eligible to be nominated for any event for the first time-
- (a) the greyhound, together with the Certificate of Registration issued in respect of the greyhound, shall be presented to a steward, or other authorised person, for identity verification;
  - (b) written evidence of the kennelling of the greyhound in such form as prescribed by the Authority shall be lodged with the Authority; and

*Notification shall be as in writing, by email or by the lodgement of the prescribed Kennelling Form.*

- (c) veterinary certification in such form as prescribed by the Authority, of an inoculation of the greyhound, after the age of twelve (12) months, of at least the C3 booster and such other inoculation as the Authority may prescribe.

*The certification shall be as in written form identifying and signed by the veterinarian.*

**LR38** The owner, lessee and any other person with an interest in a greyhound to be nominated for a claiming race must complete the prescribed form and lodge it with the Authority.

*The prescribed form shall be the Authority to Nominate & Transfer A Greyhound In Claiming Races form.*

*The prescribed form shall be the Claiming Form (to enter a claim).*

**LR46** (1) A person aggrieved by a decision, other than a reprimand or a fine of less than an amount prescribed by the Authority, of a club, Stewards or an Authority officer, which adversely affects the person, and for which an appeal is not available under the Act, may appeal to the Authority in accordance with these Rules.

*A fine of no less than \$150 and not greater than \$250 imposed on a person by the Authority, a club, stewards or Authority Officer may appeal to the Authority in accordance with these rules.*

**LR46** (3) A person desiring to appeal against any decision shall within 14 days of the giving of the decision lodge application in writing with the Authority together with any prescribed fee and a statement of the nature of the decision to be appealed from and the grounds of the appeal. Except by leave of the Authority or Appeal Panel, an appellant shall not be entitled, on the hearing of the appeal, to rely on any grounds not so set out or on any matter of which particulars have not been given.

*The fee to appeal is \$100.*

**LR65** A bookmaker shall-

- (1) in respect of all betting transactions entered into, retain the relevant betting sheets or other approved records system for such period as prescribed by the Authority;

*The prescribed period shall be 5 years.*

**LR76** (1) The Authority may prescribe the maximum amount a bookmaker is required to accept for each bet. The amount prescribed may be fixed by reference to a racecourse or part of a racecourse.

The prescribed amounts shall be-

The amount of the bet on a race conducted at a Metropolitan thoroughbred meeting shall be a least \$200 or the amount of the possible winnings from the bet shall be at least \$2000, and on any other bet at least \$100 or the amount of the possible winnings from the bet shall be at least \$1000.

Notwithstanding the above a bookmaker shall not be compelled to stand to lose more than \$200 the place and \$300 any other bet in regard to any bet placed on a race for maiden greyhounds.

A bookmaker shall not be compelled to stand to lose more than \$400 the place and \$600 any other bet in regard to any placed on a non TAB race held at a TAB meeting.

**LR93** If in any race the stewards at the meeting where the race is to be conducted permit or order a runner to be withdrawn from the race or if they declare a runner to be a non-starter in the race, the stewards at a meeting where betting is conducted on that race shall prior to the declaration of all clear or correct weight signal, as the case shall be, being given declare that-

- (a) all bets made on that runner on the day on the race be refunded: and
- (b) bets on the remaining runners n the race, made on the day of the race and before such happening shall stand, but that:
  - (i) bets for a win;
  - (ii) bets for a place;
  - (iii) bets on 1 runner to win and another to run second (forecast bets);
  - (iv) bets on 2 runners to run first and second irrespective of order (quinella bets);
  - (v) concession bets on the winner: and
  - (vi) double bets;

shall be subject to a variation to be determined by the stewards in accordance with the table of deductions prescribed by the Authority.

The prescribed table shall be-

The deductions and premiums to be added applicable to races shall be in accordance with the deductions/premiums determined by the Stewards officiating at the meeting where the race is conducted in accordance with the Rules applicable to the place where the race is conducted. PROVIDED that if a declaration concerning deductions/premiums is not made by the Stewards officiating at the place where the race is conducted, the Stewards officiating at the place where the bet was made shall determine any deductions/premiums in accordance with the Table of Deductions/Premiums.

**When 2 or more runners are withdrawn SIMULTANEOUSLY the rate of deduction from and premium added to winning bets made prior to that withdrawal shall be determined by ADDING TOGETHER the rates of deduction/premium determined in respect of each such runner.**

**The amount payable to a bettor shall not be less than an amount which represents odds of 1.05 except:**

- (a) where the bet was made at odds shorter than 1.05; or**
- (b) where the amount otherwise payable is halved or otherwise reduced as a result of a dead heat.**

**In all cases the amount to be paid to a bettor shall be calculated to the nearest 5 cents.**

**Where withdrawals occur at 2 or more different times the rates of deductions from and premiums added to winning bets:**

- (a) prior to the time of the first withdrawal: and**
- (b) between the time of the first withdrawal and the time of the second withdrawal or between subsequent withdrawals, shall be determined as follows:**

- (i) Winning bets made prior to the time of the first withdrawal:**

**Determine the rate of deduction from and premium added to for bets made on the FIRST withdrawn runner at the time of withdrawal disregarding the fact that there is a second withdrawal, using Table A.**

**Determine the rate of deduction from and premium added to bets made on the SECOND or subsequent withdrawn runner at the time of the second or subsequent withdrawal using Table A.**

**Add the two amounts of deductions/premiums together and apply this deduction/premium to all winning bets made prior to the first withdrawal.**

- (ii) Winning bets made between the first withdrawal and the time of the second withdrawal:**

**Determine the rate of deduction from and premium added to for bets made on the seconds withdrawn runner at the time of withdrawal using Table A.**

**Apply the deduction/premium to all winning bets made between the first withdrawal and the second withdrawal.**

- (iii) Winning bets made between the second withdrawal and any subsequent or further subsequent withdrawal:**

**Determine the rate of deduction from and premium added to for bets made on the subsequent withdrawal or any further subsequent withdrawal.**

**Apply this deduction/premiums to all winning bets made between the second or any subsequent withdrawal or any further subsequent withdrawal.**

**In all cases the amount to be paid to a bettor shall be calculated to the nearest 5 cents.**
